Saturday- Ring 1- Instinct T1, Novice T1, Novice T2, Open T1, Open T2, Senior T1, Senior T2,

Saturday -Ring 2- Crazy 8's T1, Master T1, Crazy 8's Trial 2, Master T2

Sunday- Ring 1- Instinct T3, Novice T3, Novice T4, Open T3, Open T4, Senior T3, Senior T4

Sunday- Ring 2- Master T3, Crazy 8's T3, Master T4, Crazy 8's T4

The running order will be posted at the score table for each trial. All requests for running order changes must be approved by the Trial Secretary.

Master Blind:

Master Blinds will be 4 dogs All other blinds will be 5 dogs

Awards:

Awards are handed out at the awards table. No awards will be mailed.

All classes:

Qualifying Score: Brown Flat Ribbon

Novice and above:

Rosettes are offered for new titleholders.

High In Class Rosettes

Qualify in both trials on the same day?: Award medal - BLING!!!!

Ribbons are offered for First through Fourth place in each height division.

Venue:

Exhibitors will be crating under cover at the arena. Should be plenty of crating space. All Dogs Sports Park reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack water for you and your dog. There is no food on site so please plan accordingly.

Notice to Exhibitors:

- This event is open to all dogs 6 months of age and older.
- The show committee has the right to refuse any entry.
- Any of the Judges of Record for this event may be used to judge any of the classes at this event at the discretion of the Club under the rule provisions for Load Balancing, Relief Judging, and Splitting. Qualifying scores are assigned to the official Judge of Record for that class.
- Withdrawal of entry before the closing date will receive a full refund.
- Refunds for dogs pulled before closing will be mailed 7 days after the event.
- **No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee. Exception - Injured dogs with a note from their Veterinarian will receive a refund**

less the \$5 processing fee.

Exhibitors are responsible for complete, accurate and legible information on their entry forms.

- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when in the ring.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to Redwood Ratters. There is a 10% convenience charge for payment by PayPal with a max of \$10. Entries where payment has not been received within 7 days of receipt of entry will be cancelled.
- Maximum of 5 entries per envelope.
- Trials site and judging ring are handicapped accessible.
- Bathroom facility is on site
- At no time can dogs be tied out or otherwise left attached to anything other than a human when outside a crate, car, or other secure enclosed confinement. Leashes cannot be left dangling or dragging. Standing or stepping on a leash is not allowed as a form of restraint (but may be used in an emergency to help secure a loose dog.) Accommodations to this rule may be made for differently-abled handlers as determined by the Club

Check in;

Check in begins at 7:30am - Trial begins at 8:00 AM. Estimated start times will be used for this trial. General Briefing will be held at 7:45 AM Dogs may enter both Instinct and Novice in the same trial until the dog has earned the RATN title. A dog that has earned an RATN may no longer enter the Instinct Test. Exception: If the dog is already entered in Instinct at the trial and earns its Novice title, it may continue to compete in Instinct for that weekend only. Dogs must be eligible to run a class at the time of entry.

Results

Please check your results at the event. It is much easier to fix an incorrect score BEFORE the results are sent into Barn Hunt Association. It is the handlers responsibility to make sure all information and scores are correct.

Parking:

Area will be on the paved area next to the pool and lake lawn.
