- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$25 fee for any returned check or payment. Checks must be made payable to All Dogs Sports Park LLC.
- All Dogs Trails and Tails reserves the right to refuse any entry without cause or explanation.
- Trial begins at 8:00 AM.
