In the case that there is a tie of combined scores and combined times, the winner will be determined by run-off at the conclusion of Rally judging using the Excellent B course used earlier in the trial. Handlers may have five minutes to re-walk the course.

- Any exhibitor with a bitch entered which comes into season after the close of entries will be refunded the entry fee for each entry for that bitch less a \$5.00 processing fee. Request for refund of entry fees must be provided to the Trial Secretary not less than 30 minutes before the start of the trial.
