- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run. There will be no resets once the class is closed.
- Please be courteous and pick up after your dog.
- No alcohol or fireworks are allowed on trial grounds.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$25 fee for any returned check or payment. Checks must be made payable to All Dogs Sports Park LLC.
- All Dogs Trails and Tails reserves the right to refuse any entry without cause or explanation.
- Trial begins at 8:00 AM.
